### Implementation of video games into ELT and its effect on development of language competencies of lower-secondary students

# A Comparative Morphological Analysis of One Hundred Swadesh Terms in Ilokano and Mernao Language

Mernao and Ilokano language are among the widely spoken languages in the Philippines. Yet, topographically these languages have been spoken by speakers who are living in separate islands, the former is the native language of Maranaw people who live in Lanao province of Mindanao. Whereas, the latter has been used in both Northern and Central Luzon, and is the third most-spoken native language of the country. This study then is focused on comparing the morphological structure of one hundred swadesh terms of both languages.

Based from the analysis there is a forty seven percent difference in the morphological construction. Yet, in spite of this number , there is still a ten percent similarity identified .The remaining forty three percent of the words undergone some alterations due to morphological processes such as affixation, vowel and consonant modification , glide formation , reduplication or a combination of other word process. Both of these similarities and minor alterations comprised fifty three percent of the data, meaning there are more similarities rather than differences in the swadesh terms that could be explained since both languages belong to the Austronesian family of language.

Angela Carter, an author who redefines the Gothic genre through a feminist lens will be examined in her exploration, deconstruction and subversion of the male-gaze as she coins the so-called 'female gaze in her short story, The Bloody Chamber. The main focus will be upon the protagonist and her mother secondarily through De Sade's 'Juliette and Justine' archetype studies, and will be contrasted similarly to other crucial women in the Gothic genre, Mina and Lucy in Stoker's Dracula. It will be discussed how characters in both texts may conform or subvert the conventions of the male gaze.

# Gender in Shakespeare and the Teenage Rom-com

This essay will explore the presentation of gender in Shakespeare's The Taming of the Shrew and its 1999 movie adaptation 10 Things I Hate About You. Using Butler's theory of performativity, which chronicles the idea that gender is socially constructed through the act of performance, the essay will discuss the ways in which both texts represent gender expectations of their times. The focus will be on a comparison between Katherine and Kat, the respective protagonists of each text, and how their points of gender conformity can be compared and contrasted to show the differences in expectations of women between the Elizabethan Era and the late 19th century. The use of Butler's theory will allow for a closer analysis of the turning points for both characters, assisting in the argument for whether both scenes attempt to satirise their respective time periods' gender expectations or simply present them.

# Is It Possible to be Non-Religious According to Maps of Meaning?

Maps of Meaning proposes an interdisciplinary understanding of good and evil through psychological and philosophical lenses, supported by anthropological and cultural-historical evidence.

The aim is to demonstrate the plausibility of the impossibility of being non-religious, through deliberation and expansion of the implications carried in the central discussion of Maps of Meaning. This central discussion concerns how, by definition, regardless of whatever form that god takes, is that which a person utilises to abstract and construct meaning; interpreting, interacting and manufacturing an idea of the world, thus making sense of life.

From this it is possible to conclude each person possesses an intrinsic need for a hierarchy of values – otherwise there is formation of destructive confusion. # Shakespeare: Original or some help from The Muses?

This study examines the relationship between the works of Shakespeare and the inspiration Shakespeare has taken from Greek Mythology. # Prescribing The Future: Navigating the AI frontier in Pharma Startup Dynamics

This research investigates the influence of Artificial Intelligence (AI) on competitive strategies within the pharmaceutical startup landscape. Employing a quantitative approach with purposive sampling, data is sourced from public documents and the openFDA API. Market research underscores AI's transformative potential, notably in Research and Development (R&D), enhancing startups' agility for swift market entry. Computational analysis reveals a statistically significant inverse correlation between total drug submissions and FDA approval rates, challenging the presumed competitive advantage through increased production. This contradicts the hypothesis that more submissions lead to higher approval rates. Implications suggest that, while AI augments R&D capabilities for startups, the anticipated competitive edge may not be as substantial as expected. Findings call for a reassessment of assumed connections between large firms' FDA submissions, approval rates, and startup competitiveness.

# The Analysis of Risk in the Undertaking of Security Management - A Evaluation of Password Fatigue

Passwords are the first line of defence and are ubiquitous in modern life. However, the fatigue passwords cause, contribute to insecure methods. Sharing, reusing, and writing them down have become ingrained habits, limiting their effectiveness. Individuals know what good passwords entail, nonetheless, they engage with risky behaviours due to the fallacy 'it will not happen to them'. Passwords are integral to cybersecurity at all levels, making understanding what makes humans the weakest link fundamental to data protection. The fear, reluctance, and anxiety in dealing with passwords and cybersecurity are often described as 'security fatigue'. This concept is often used interchangeably with 'password fatigue'. Even though the issue of password fatigue applies to people of all ages, backgrounds. and nationalities; most of the current research is based on IT professionals or those that work in technology professions. University environments are underrepresented, contributing to an unclear picture of the effect of password fatigue on end users in an environment that is a prime target for bad actors. Using data collected via a questionnaire that involves participants creating and remembering passwords will examine a potential link between the strategies and their importance while establishing a more genuine response. There is an expectation that the most common passwords are not being used. however, the probability that some participants are rehashing, organising, and developing easy to guess and crack passwords combinations is highly likely.

### Why are individuals re-criminalised?

Re-criminalisation has been increasingly prevalent in the UK in recent years at a rate of 30.9%. There is an existing correlation between vulnerable backgrounds and individuals being re-criminalised, which sees 67% from low-income backgrounds. This project is Investigating the underlying causes of vulnerable background individuals seeing higher rates of re-criminalisation. 57% of these individuals have historic and existing family drug misuse, hence it being a predominant cause. This example is one of many dynamic risk factors. This ultimately means changing circumstances that increase the likelihood of re-criminalisation. Individuals from vulnerable backgrounds are re-criminalised the most. Their circumstances are overcome by dynamic risk factors that create scope for their re-criminalisation. The main focus of this project is understanding why.

# The additional gender-based toll of custodial sentences for women in England and Wales.

Given that 95% of the prison population in England and Wales is male the prison system is adapted to their needs. This study aims to address the additional gender-based toll women face during custodial sentences. Previous studies have indicated the psychological impact that the prison system has on the mental wellbeing of women, with more than 41.6% of imprisoned females screening positive for a current mental health need. These issues arise from the societal stigmatisation of being a criminalised woman and being deemed an 'unfit woman'. The goal of this research is to highlight government plans aimed at reforming the system and conduct an analysis of the current situation, to assess if what is being done is sufficient. The research found that despite rehabilitation programmes like the Together Women's Project and Birth Companions there are still limitations to their effectiveness, for example due to the lack of accessibility.
